### **Costs**

### **APPLICATION DEADLINE: June 3, 2009**

#### **Program**

Three sessions daily with small groups, several pits and large staff on premises the entire camp. Variety of activities including vaulting, gymnastics, imitative exercises, vaulting drills, videotaping, strength and speed testing, age group competitions and other recreational activities.

#### **Housing and Meals**

Residents will be housed and fed at the Fairfield Inn Centerville (937) 428-7736.

#### **Registration**

A check for \$100 down payment should accompany your registration form. The balance of your camp fee will be due at check-in. Participation in the camp is available on first-come, first-serve basis. Registration deadline is June 3, 2009. Upon receipt of your application, you will be mailed a confirmation letter with detailed instructions and camp information.

#### **What To Bring**

Each vaulter should bring his/her own helmet, poles, shoes, shorts, sweats, towels, toiletries, pillow, sheets, blanket, alarm clock, tape and extra spending money. Arrangements can be made to borrow poles but it is best if you bring your own. Detailed information will be mailed to you upon receipt of your application.

#### **Coaches Education Program**

Coaches who participate in a Sky Jumpers Vaulting Camp either as a participant or registered observer may qualify for our special tuition waiver (\$100) by contacting us 30 days prior to our camp. Tuition waivers are limited to first come first serve basis only. Coaches must be at least 21 years of age with a high school or college coaching job.

#### **Pole Vault Coaching Certification**

All SJVSC camps are now formatted to so as to help their participants to pass the new National Pole Vault Safety and Basic Skills and certification course at [www.pvscb.com](http://www.pvscb.com). This course is designed for both coaches and athletes.

#### **Check In**
